

# CAR Foundation Receives Grant from REALTOR® Relief Foundation to Help with Colorado Wildfires

The CAR Foundation, in conjunction with the Colorado Association of REALTORS®, was awarded a \$100,000 grant by the National Association of REALTORS® REALTOR® Relief Foundation to help individuals and families affected by the East Troublesome, Calwood, and Cameron Peak Fires (Boulder, Grand and Larimer counties).

Qualified applicants can receive up to \$1,000 to be used exclusively for a monthly mortgage expense on a primary residence or rental housing cost due to displacement from a primary residence or rental relocation resulting from a qualified fire area.

Applications for the grants are available on the <u>CAR website</u> or under <u>Colorado Project Wildfire</u> and the <u>CAR Foundation</u>. Applications should be sent to <u>CARF@coloradorealtors.com</u>.

Grants will be disbursed on a weekly basis. However, it could take up to two weeks to receive the certified check by mail. Checks will be jointly payable to applicant and mortgage lender or landlord.

Funds will be available on a first come, first serve basis and will be available beginning immediately through February 15, 2021.

# **REALTORS® RELIEF FOUNDATION Application for Disaster Relief Assistance**

## Type of Assistance

Assistance is available to qualified applicants towards one of the following options: 1) Monthly mortgage expense for a primary residence that was damaged by the Colorado East Troublesome, Calwood and Cameron Peak fires and or; 2) Rental housing cost due to displacement from a primary residence or rental relocation resulting from qualified fire area. Relief assistance is limited to up to \$1,000 per applicant per household. Deadline for application submission is February 15, 2021 or until funds are depleted. Please note this assistance is for primary housing or rental relief only; other expenses including second mortgages(home equity lines or loans), hotel/motel expenses, clothing, appliances, equipment, vehicle purchase, rental or repair and or mileage are NOT ELIGIBLE under this program.

## **Eligibility**

Recipient must be a full-time resident and U.S. citizen or legally admitted for residence in the United States.

### **Confidentiality**

All information provided on this form will remain confidential and will be available only to those who need to confirm eligibility for assistance and to those who process the assistance to be provided. This includes providing a copy of this application to the applicant's lender or landlord, if requested. It will not be shared with other parties for any other purpose.

## Disbursement of Funds

In order to provide for a reasonable and equitable distribution of funds, assistance will be provided on a first come, first serve basis. All grants are contingent upon the availability of funds. Grants will be jointly payable to applicant and mortgage lender or landlord.
